GPX Event Privacy Notice

This privacy notice tells you about how the Good Practice Exchange (GPX) of the Wales Audit Office (WAO) processes information collected about you when you register and/or attend a GPX event as a delegate, facilitator or contributor. Events can include shared learning seminars or webinars and Wales Audit Office events.

Who we are and what we do

The Auditor General for Wales' work includes examining how public bodies manage and spend public money, and the WAO provides the staff and resources to enable him to carry out his work. This includes the GPX which seeks to help public services improve by sharing knowledge and practices that work.

The relevant laws

We process your personal data in accordance with data protection legislation, including the Data Protection Act 2018 (DPA) and the General Data Protection Regulation (GDPR). The GPX processes your personal data in provision of services under section 19 of the Public Audit (Wales) Act 2013.

What we will do with your information

We collect information from you so that we can plan and manage our events and afterwards to facilitate and encourage sharing knowledge and best practice between attendees and contributors.

The GPX team and, where necessary, other staff from the Wales Audit Office will have access to the information you provide. We may share some attendee information with contributors and facilitators prior to the event to assist with planning the event and event content.

After the event it is our usual practice to share a list of attendees (including name, role, organisation and email address) to facilitate the exchange of knowledge and resources. **If you do not want to be included on this list you must notify us prior to the end of the event.**

We will keep your personal data for the periods specified in our Documents and Records Management Policy and we will hold your data securely in accordance with our Information Security Policy.

Photographs, Recording and Videos

We transmit webinars live to an online audience and we record webinars and subsequently make the recordings available through the Wales Audit Office website and YouTube channel. Webinar speakers may also share the webinar video with their organisations and contacts.

During seminars we may take photographs and produce short video clips of each presenter on the day of event, covering the key points of the presentation. Photographs and videos may be published on the Wales Audit Office website and video clips are shared on the Wales Audit Office YouTube channel.

If you are speaking or presenting at an event and do not want to be recorded you must notify us in writing prior to the event.

Your rights

Under data protection law you have rights to ask for a copy of the current personal information held about you and to object to data processing that causes unwarranted and substantial damage and distress.
